Great news on owning a chunk less money Shaun. Shaun can you and I connect this week on the membership emails? I've just had a big deadline pass at work so I have a little freedom for the next couple of weeks. Perhaps Thursday or Friday?

Alex - thanks for the start on the content calendar but I think we need to start by looking monthly for the next say six months and then break it down to something we can cope with.

GDPR - I know we are not campaigning on it but as it starts this week it would be useful to have either a statement or a stand on the type of material we will rt/post on FB etc. Data privacy will be hot for a week or so.

Re new board members - before we get to looking at individuals we need to decide if a) we want to bring on any more before the AGM - appointee's will need to stand for election anyway, and b) how to have a

transparent secondment process in place. To this end I've found a couple of good board audit templates - one from Amnesty International and one for school governance boards - between the two of them I think I can come up with a nice form - so I'll do that this week to get a draft - I've put these two documents in the governance folder in Owncloud

Office hours for volunteers - I have been thinking about how we could onboard and support volunteers - having clearly defined roles is the first step and something I'd like us to think about - esp around comms, membership management and other administrative tasks. Then the other side is managing and supporting them. If we were able to "staff" a couple of hours per week of office hours it would be a big help - ie people knowing that between 1-3pm on a Friday there would be someone available to check in, ask questions, have a zoom meeting etc.

Last Friday Peter and I attended the not called Australian Internet Forum meeting for organising a business case workshop that is certainly not exclusionary - or AulFMBCWTCNE for short ;) - they are meeting every three weeks and organising the participant list. Peter might be able to remember what they asked us to do. They've found funding for me to go I believe and Peter couldn't make the date anyway July 19. While I'm in Canberra it would be worth thinking about if there is anything EFA related I could do, like a heaps cool stunt or a very sensible meeting.

## Treasurer's Report
